REGISTRATION, CANCELLATION & REFUND POLICY

AWHONN Fetal Heart Monitoring Courses

COURSE REGISTRATION

Pre-registration is required for all courses. Registration is not confirmed until payment is received in full. Class sizes are limited and seats are reserved on a first-come, first-served basis.

- Payment must be received no later than one (1) week prior to the course date
- Registration takes 24-48 hours to process; your patience is appreciated.
- **Students are responsible for ordering required AWHONN Student Materials directly through Kendall Hunt Publishing prior to the course date (ordering instructions included in confirmation email)**
- Students who have not purchased required materials will not be permitted to participate and will forfeit their registration fee

REQUIRED MATERIALS (NOT INCLUDED IN REGISTRATION FEE)

CANCELLATION BY STUDENT

CANCELLATION OR RESCHEDULING BY REDWOOD CONSULTING
